## NEW STANDING RULES ADOPTED FOR PSRMA

Two new standing rules were presented by President Kerr and adopted at the July 6th Board of Directors Meeting:

- i. The issue of REPORT published 3 weeks prior to the fourth quarter General Meeting shall be known as the Election Issue; and further, the REPORT editor is to obtain a campaign statement from each nominee and encumbent for elective positions for presentation to the membership.
- ii. All nominees for elective office in PSRMA are required to make a campaign statement in REPORT. This statement is to convey the nominee's philosophy and expected contribution to the furtherance of PSRMA objectives.

These standing rules have been adopt-(continued on top of next column) ed by the Board of Directors and are now in effect. The next issue of REPORT will be the Election Issue, and all nominees should send their prepared statements to REPORT Editor John Hathaway, 4215 Dwight Street, San Diego, California, 92105. The deadline is October 1st, so start preparing your ideas now.

## REVIEW COMMITTEE MEMBERS ALSO NOMINATED

Also nominated at the July General Meeting were two members to serve on the little known, but potentially important, Review Committee. This Committee, if a case arises, will review on demand of any five Regular members any action taken by the membership, the Board of Directors or any member thereof, any executive or administrative officers or subofficers, or any individual member. The Review Committee, upon receiving such a request for investigation from any five regular members, is responsible in deciding the legality of the questioned action with regard to the Association's Articles of Incorporation, bylaws, the laws of the Federal government, and the laws of the State of California. The Review Committee's findings are then made known to the Board of Directors, and if proper action is not taken at that time by the Board or General membership the Committee is then required to take necessary legal action to rectify the discrepancy.

In other words...the Review Committee is a safety valve inserted within the Association's structure to protect the best interests of PSRMA and its goals. The reason this very important committee is often forgotten is because it has never had to take any of these actions. But it is still there. Members nominated this year to Review Committee are Eric Sanders and Stan Kerr.
